Annual Meeting:

- Thank you to all who attended and contributed. Feedback will reflect in changes to this call's future format and other internal changes. Additional information to be shared during the July call.
- Appreciated topics that were received for future meetings.
- Annual meetings will be in-person during even numbered years and virtual in odd numbered years going forward.

Staffing:

- Announced Kim Thibodee as the new NWCG Administrative Assistant.
- Currently filling 3 A/V Specialist positions. The announcement has closed, but have not yet received the cert.

Incident Performance and Training Modernization (IPTM) update:

- Discussed the need to stick to the established schedule for contracting requirements and cost
- 2023
 - o 10 positions have completed analysis, and most are in design or development phase
 - o Thank you to committees and SMEs for their commitment which is critical.
- 2024
 - o 16 positions will start analysis at the end of the month and start of May.
 - o Recommendation reviews will occur June-July for the Incident Position Description (IPD) updates, and development of Next Gen PTB and Incident Position Standards (IPS). Then that will move into the review phase 1 (due July 8-Aug 5).

Next Gen PTB:

- Quick review of IPTM Performance Support Package for NWCG incident positions
 - o Incident Position Description (IPD) is the 'what', Incident Position Standards (IPS) is the 'how', and Next Gen PTB is for evaluation.
- Next Gen PTB is structured into three main sections
 - o Front verification page consolidate what was the first few pages to one page to streamline.

Evaluation Table – four ratings for each task. Includes only required tasks for successful performance, noted in the IPS by an asterisk, designed to be used in conjunction with IPS baseline standards for operation in the position.

- o Evaluation Records very similar to the older "classic" PTB version. The added Remarks Section enhances feedback to the trainee and home unit to support constructive conversations.
- Can use multiple codes for type of assignment flexibility (new S code for simulations).
- Must rate each task, even if N/O, and must have M or E for all tasks for certification.
- If more than four columns are needed, add another position evaluation table (not required to use all four evaluation columns).
- Transition from Classic PTBs to Next Gen PTBs:
 - o Classic PTBs will go away when the Next Gen PTB is published through IPTM.
 - o For combined PTBs, the classic position-specific duties will be removed from the combined PTB.
 - o Completed common tasks in classic PTB (i.e., the Single Resource Boss positions) will not need to be repeated.
 - O Start and finish in the same PTB, no need to merge or start a new PTB.
- Spring 2024 and moving forward
 - o Many more IPTM positions are slated for completion soon, including CRWB, OPBD, MEDL, and RXB2
 - See position pages for all products.
- Will post transition plan and video to the PTB page after web migration has finished.
- Reminder to sign up for NWCG emails by functional area to get information.

EB meeting prep and handouts:

- To better prepare for Exec Board meeting, handouts are due 6 weeks in advance.
- Allows other committees and NWCG staff to have time to coordinate, answer questions, and review.
- A checklist is being drafted to facilitate the process (from an annual meeting feedback suggestion).

Web Migration Update:

- Started January 2023 and is very close to finalization.
- Rebuilding required going from Drupal 7 to 10 which adds functionality.
- Also involved moving to a cloud AWS server through the domain team.
- Delayed from November 2023 due to the change from Drupal 7 to 9, then Drupal 9 to 10 new requirements during the migration for InciWeb and LLC sites before the web team could continue working on NWCG.
- Resolved 99% of tickets and built over 7,000 pages.
- Attempted to go live on April 2nd but only the development server was live and had to delay. Awaiting a green light from Amazon (AWS server) for critical web traffic to flow. Current site is kept live in the meantime.
- Improvements:
 - o Large file upload support with centralized storage.

- Three environments: production, development, and staging.
- Webforms now allow attachments.
- o Improved printing as single PDF download sitewide.
- o EDG/Drupal full integration can now view NWCG Glossary in viewable web format.
- o Announcements now have a create once and share throughout the site option.
- o Navigation now has landing pages and streamlines to main audience needs.
- o Queries and filters (PMS 504 directory as example) in content and contact lists.
- Post-migration: team continues to meet and make corrections, analytics, feedback, testing to allow other sites to embed our content, and more ED6 integration.

IPSC:

- PMS 310-1 errata (expected release in June).
 - Positions moving from the Fed Supplement to 310-1 (ARCH, READ, REAF, REAC). Will not be in the errata.
 - 2 OPBD pathways and the Next Gen PTB.
 - Other RFCs for decision April/May.
- IMT Courses
 - The advanced course will start analysis this fall for Dec 2025 deadline (reminder: Field Eval goes away in Jan 2025). S-320, Intro to IMTs, is on schedule for the Dec 2024 deadline with the alpha pilot June 25-27 in Sacramento, CA and the beta pilot September 3-5 in Madison, WI.
- Working on an RFC for LOFC and the ICCI pathways.
- Spring annual meeting is next week in Bend, OR.
