## TOPIC

### Review Current Actions:

#### Complex Incident Management Implementation

- IPSC Request for Input on ICCI Pathways
  - IROC data shows nearly 200 total qualified T1/ICCI, but many are in high-level agency positions that preclude mobilization and several are ADs.
    - Data to add context would be number of qualified ICCIs deployed in 2024.
  - Focus on the skill and ability of personnel that can complete the job in the future, not only the current IC pool.
  - IWDG supports providing multiple alternate pathways such as qualified Command and General Staff positions qualifying as ICCI.
  - Ask what the downsides to opening additional options for attaining ICCI qualification are.
  - IPSC will submit a formal request to IWDG for data and feedback on the ICCI pathway.
  - IWDG will update existing draft letter to IPSC with additional information for review.

#### Data Collection

- CGAC Data Call: 2024 IMT Composition
  - Additional request has been submitted for 2024 data. Two GACCs have submitted now.
  - Will start asking for 2025 data at the January CGAC meeting.

#### Open Tasking Updates

- CGAC Taskings: NMAC L2024-11: Completion of Open Taskings L2023-09 and L2023-10
  - NMAC L2023-09: Establishing Standard Criteria for Geographic Area Preparedness Levels
    - NMAC has requested support from PSOG through FMB.
  - NMAC L2023-10: Standard Alignments for Geographic Area Priority Trainee Programs
    - Task team has been created and CGAC is reviewing a draft document.
- NMAC L2023-02: Increasing Incident Support Capabilities Tasking
  - Follow up with NMAC in January.
- NMAC L2024-10: Tasking – Development of National Rotation Recommendations for 2025
  - Bender working with CGAC task team to prepare draft for discussion in January.
- NMAC L2024-12: Tasking – CIMT Configurations and T3 IMT Standardization
  - CIMT configuration task team will provide recommendation for review at January meeting.

- Type 3 configuration task team will also provide recommendation for review in January.
  - Type 3 task team will have opportunity to expand beyond configuration to more holistic view on Type 3 IMTs and personnel, to develop standards and expectations.

  - Recommendation will be sent to FMB in January.
  - Intent is to create and standardize a base AA qualification across all agencies.
